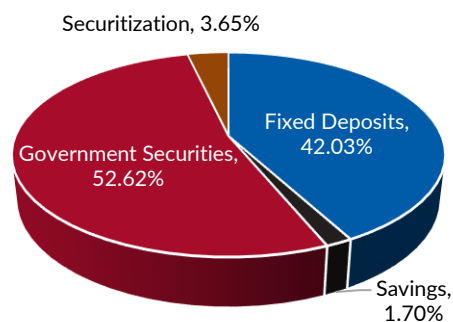

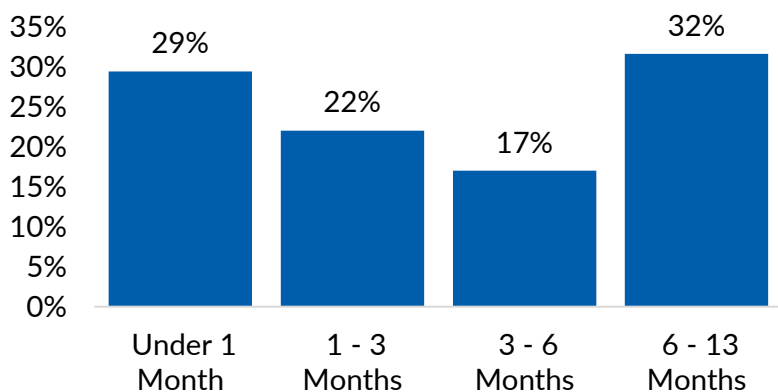

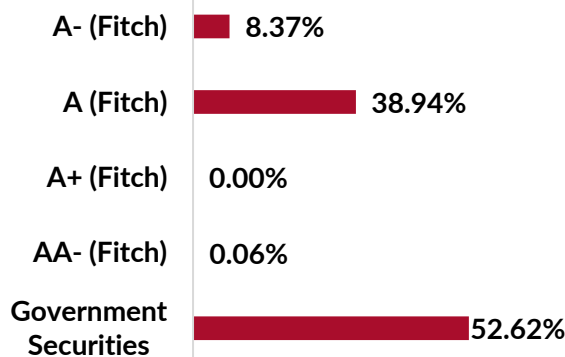
Asset Allocation
