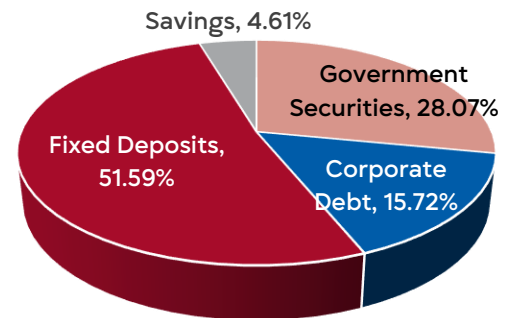

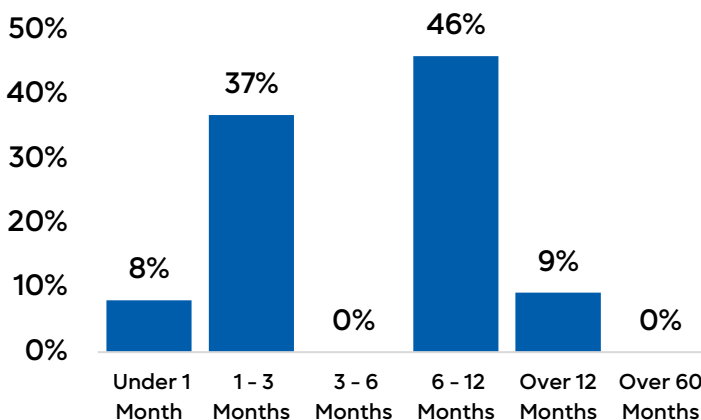

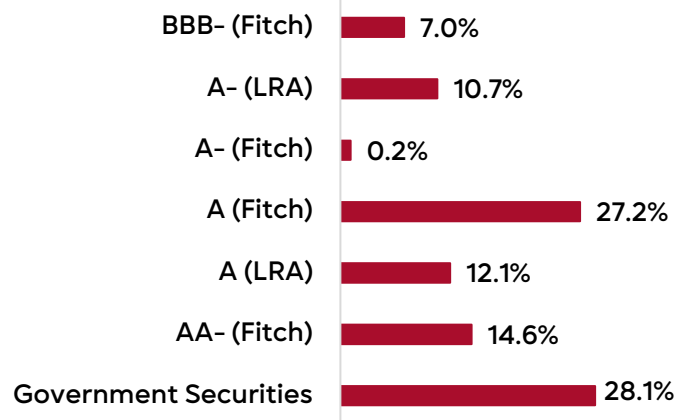
#### Asset Allocation
