Risk – Reward Indicator

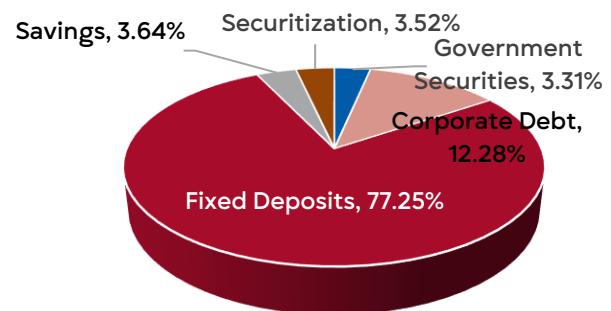

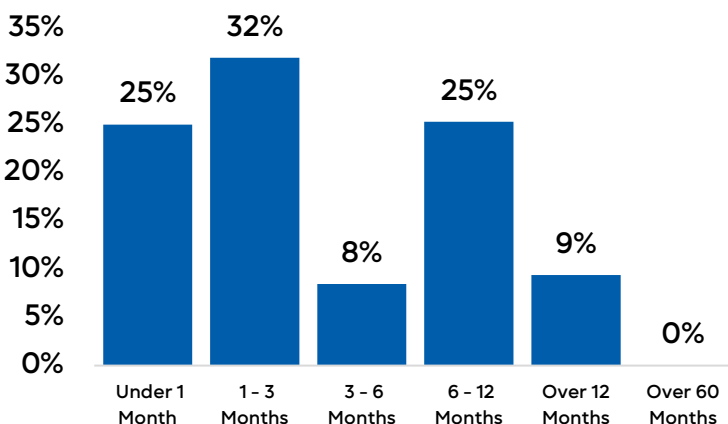

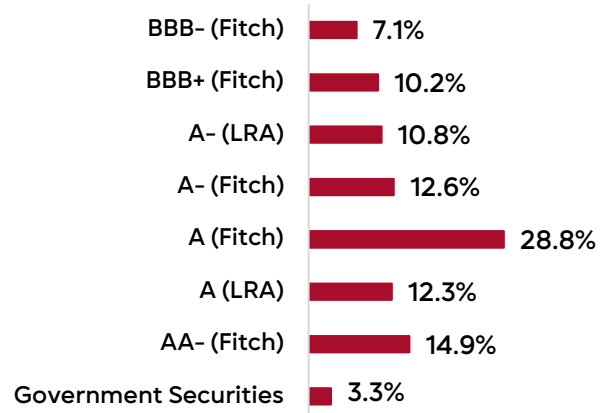
Asset Allocation
