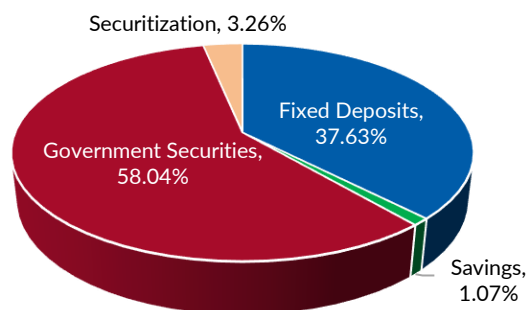

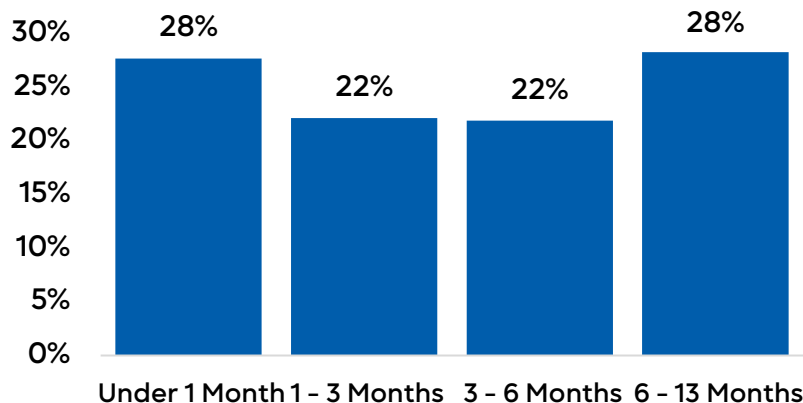

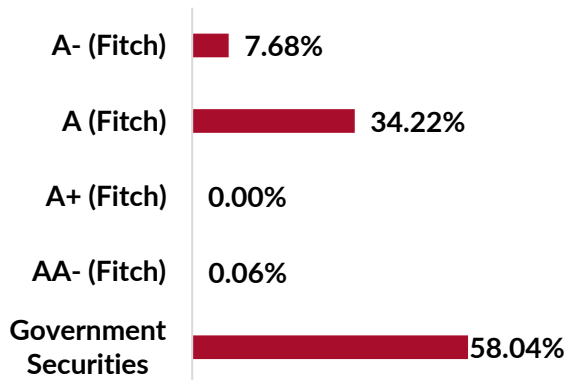
### Asset Allocation
