### Risk - Reward Indicator

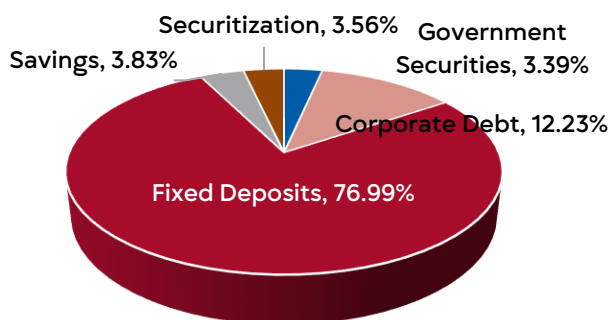

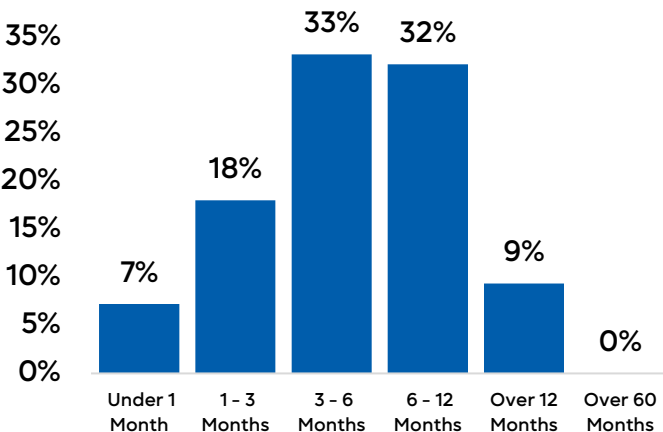
