Risk - Reward Indicator

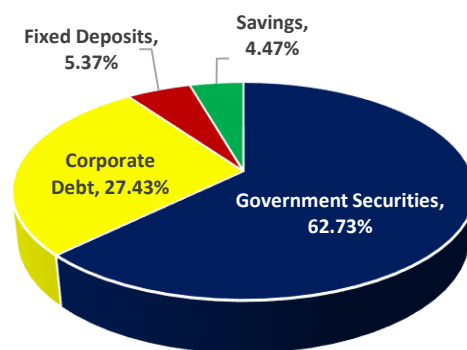

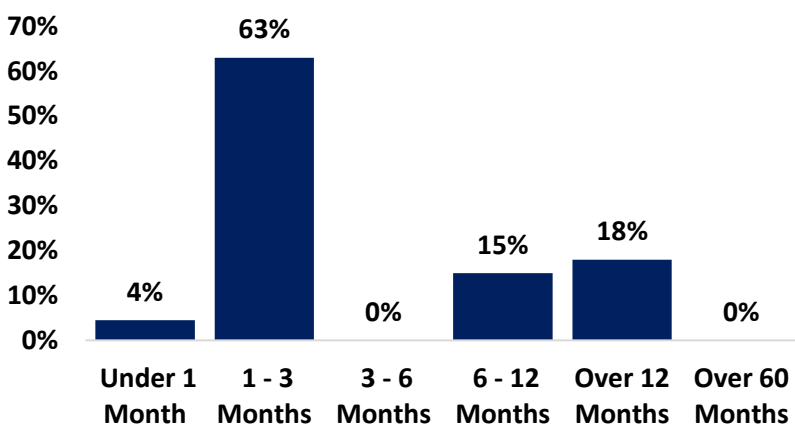

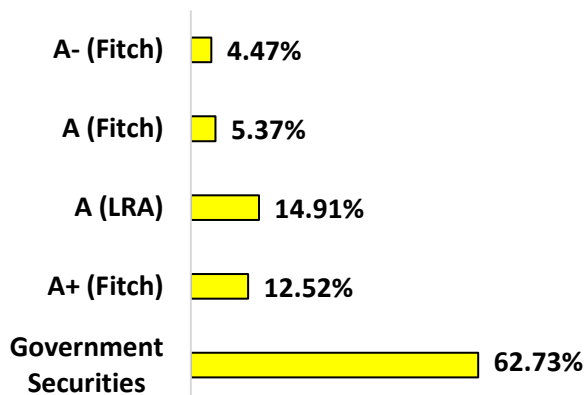
Asset Allocation
